LOOKING BACK ON 2020

This year, in particular, has been a rollercoaster of excitement and challenges.

In March, North Shore Area Partners gratefully received the donation of the former Wells Fargo bank building in Silver Bay. We began dreaming of the amazing aging services and senior support that we could provide in this spacious location at the center of town. A week later, the arrival of the coronavirus turned our focus to more immediate needs. We quickly adapted our activities to protect our clients, our volunteers and our community while continuing to reach out with additional telephone support and deliveries of supplies for older adults wishing to stay safely in their homes.

By midsummer, along with our ongoing volunteer services, we began expanding our capacity to meet the needs of older adults in our community, particularly the demand for in-home care. We increased our staffing to twelve people, including four Home Health Aides who are able to provide homemaking and personal care under our new 245D license from the MN Department of Human Services.

In November, we excitedly moved our offices to our downtown location. Again, we began dreaming of opening up our beautiful new space to serve our community. A week later, smoke damage from a nearby office fire hampered our plans. In addition, the recent surge in coronavirus cases has kept us constantly adjusting our daily operations to be able to provide continuous service to our community. Through all the uncertainty, we are adapting. Now, more than ever, our elders need us. And we need you.

KEEPING CONNECTED DURING COVID

Lighthouse Center for Vital Living - Tech to Connect Program

With a special focus on reducing social isolation, this program is for:

- any older adult
- individual of any age with vision loss
- or other disabilities
- caregiver of someone with a disability

Device loans like tablets with remote training and/or technical support can help keep folks connected with family, friends, remote events, support groups and telehealth appointments during COVID-19. This program may also include a router or hotspot for internet access as available.

COMING IN 2021 - LEGAL KIOSK

The COVID-19 pandemic and public health emergency has moved the legal system virtual, creating a digital divide that has disproportionately impacted the communities served by Minnesota Legal Aid. Access to the legal system and a chance at justice is only available to those with means and resources to use technology. To address this digital divide the Minnesota Legal Services Coalition requested CARES Act funds to give communities access to civil justice by creating a statewide network of 250 legal kiosks to be stationed in a variety of court, agency, non-profit, and other community locations.

The legal kiosk that will be placed within North Shore Area Partners will help community members have a healthy and safe way to interact with civil legal aid experts and the administrative and court systems in which their cases will be proceeding.
